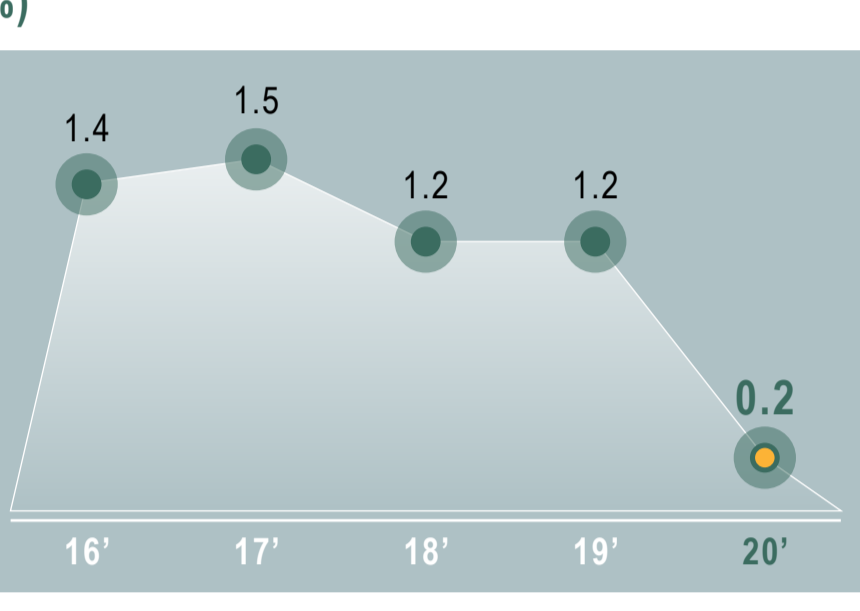

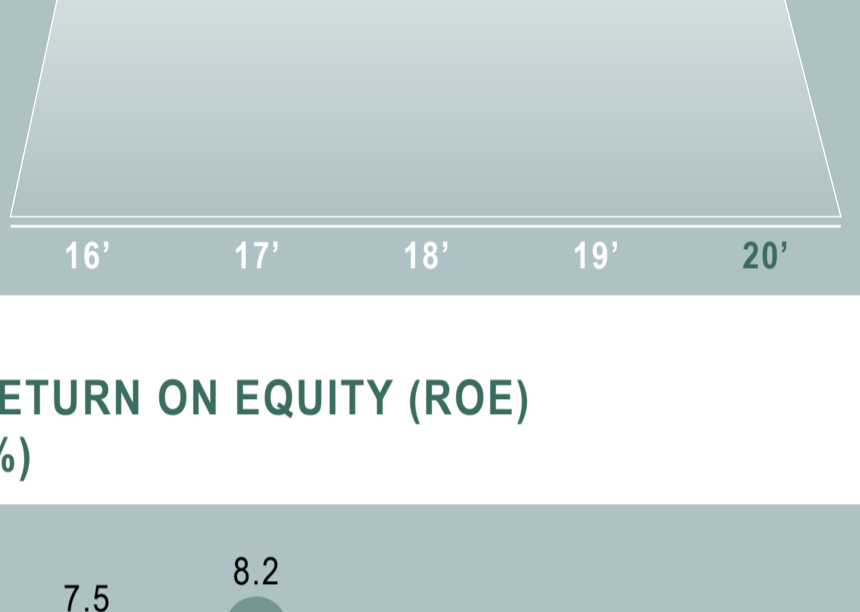

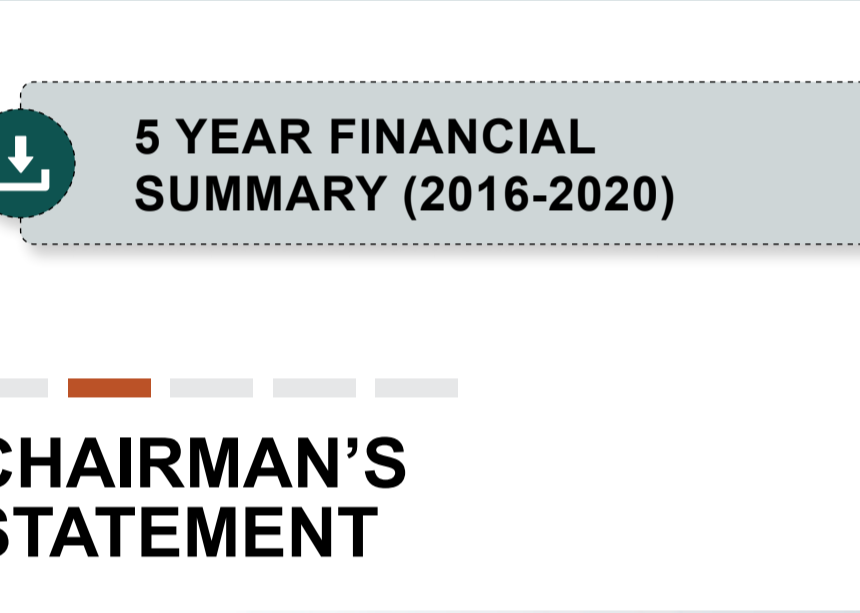
### FINANCING AND ADVANCES (NET) (RM MILLION)



### PROFIT BEFORE TAX AND ZAKAT (RM MILLION)



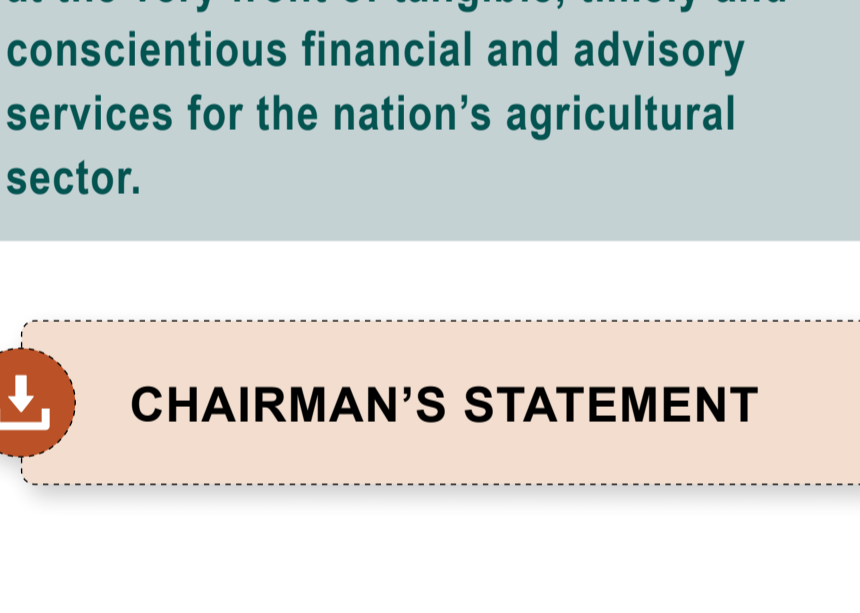
### SHAREHOLDER'S EQUITY (RM MILLION)



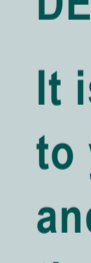
### RETURN ON AVERAGE ASSET (BEFORE TAX) (%)



### RISK-WEIGHTED CAPITAL RATIO (RWCR) (%)

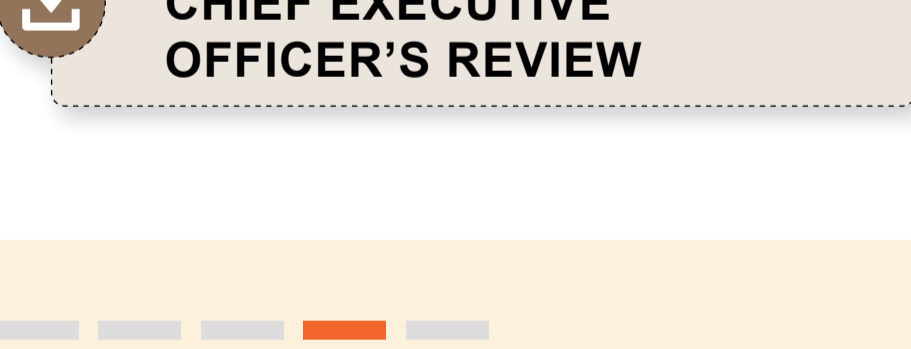


### RETURN ON EQUITY (ROE) (%)

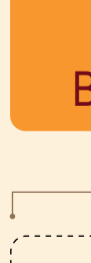
